#### 7.c Committee of Adjustment - Minor Variance - 96 Park Avenue

He further advised that walkout and parking areas would be located at the rear of the property adjacent to the St. Anne's Community Centre parking lot.

### 7.d Committee of Adjustment - Minor Variance - 44 Hickory Lane
